Duties and responsibilities

Designs local, campus, and wide area networks with an emphasis on wide area networks. Performs lead responsibilities in training, assigning tasks, and reviewing/checking the work of lower level Telecommunications Network Specialist positions. Analyzes local, campus, and WAN's regarding efficiency and effective data transmission rates. Prepares standards and procedures for these networks' maintenance and operation. Provides troubleshooting and problem support to other members of the Telecommunications Team when necessary. Designs building telecommunications cable/wiring systems in order to provide network users the ability to effectively and efficiently share and exchange data with other users on the network. The incumbent will participate on a rotating "on-call" schedule to respond to network emergencies 24/7.
