

#### QUALITY MATTERS PROGRAM OVERVIEW

based approach and continuous improvement in online education and student learning.

To advance the initiative, WVNET has purchased a statewide license for Quality Matters. In addition, the Higher Education Policy Commission (HEPC) has provided funding for training to develop a cohort of peer and master reviewers. Monies have been set aside for stipends to pay peer reviewers to review online courses which will be listed on a statewide portal.

Understanding how the rubric is applied and used as a basis for course development is essential to the course development process. The HEPC will be paying to train approximately 50 faculty on how to use the rubric. The training will be offered in both a one day face-to-face and a two week online format.

Peer and master reviewers are the key to reviewing the courses to assure they meet QM standards. The HEPC will be sponsoring 36 faculty members to establish the initial cohort of peer reviewers and six faculty members to establish the initial cohort of master reviewers. Faculty will be selected through a review process. Since each review team requires a content expert, every effort will be made to select reviewers from various disciplines.

In addition, to the faculty members that the HEPC will be supporting, institutions may opt to pay for training for additional peer reviewers for their campus. Peer reviewers are required to attend the "Applying the QM Rubric" (offered online and F2F) and "Peer Review (offered online only)" training classes. Master reviewers are required to review a minimum of two courses as a peer reviewer and then attend Master Reviewer Training (offered online only).

Finally, the HEPC has provided support for review of 36 courses that will be included in the inaugural group of courses to be posted on the statewide portal. Institutions who wish to have additional courses reviewed must first become an affiliate of Quality Matters. The cost for an institution to affiliate is \$1100 a year and is prorated based on when they affiliate. The year runs from January 15, 2012-January 15, 2013. Once affiliated, institutions can request a review team and pay the \$450.00 fee for each course reviewed. The support of the HEPC and WVNET in establishing a statewide network for QM course review results in a 50% savings for institutions who wish to have a national review process for their online courses. 
